# Robert McDonough University of North Carolina at Chapel Hill

**Teaching Experience** I have prepared and taught courses at the University of North Carolina at Chapel Hill for the past two years. I have instructed two 400-person sections of our Introduction to Economics course (covering microeconomics and macroeconomics) for several terms. Additionally, I teach a case-based principles of microeconomics course to students in the Shuford Program for Entrepreneurship once a year. I have also taught small versions of my introductory course for the Honors Carolina program, as well as upper level electives in labor economics. I also taught three courses (five sections total) at the University of Oregon while a graduate student, where I received the 2020–2021 Graduate Teaching Award for my development of an effective curriculum for my labor economics course. I can provide a statement of teaching philosophy upon request.





**Course evaluations** My course evaluations provide evidence that students consistently report high levels of learning and engagement across terms. I have summarized these evaluations on the following page. A copy of this document including all of my raw course evaluations is available on my website: (robmcdonough.com/files/reviews\_combined.pdf).

UNC uses a standard 5-point Likert scale in student evaluations. The figure below provides the mean response value for each question asked, and also summarizes my students' evaluation of my performance into coarse categories of "Agree", "Neutral", and "Disagree".

In 2019 the University of Oregon replaced quantitative evaluations with qualitative evaluations. Instead of asking for numeric ratings, the qualitative evaluations ask students to assess whether 13 different aspects of a given course are "beneficial to learning" or "need improvement to help learning." This change was driven, in part, by evidence surrounding the shortcomings of traditional evaluations [1, 2, 3, 4]. The figure below summarizes my students' evaluation of my performance according to these benchmarks.





# Selected student comments

Introduction to Economics

We were not afforded enough time and the difficulty level of the majority of the questions was beyond what an introductory course should be. I personally put in 20+ hours prepping for each midterm and did poorly on both. With that amount of time and effort, that should not be the case. The review tests that were sent out were much easier than the acutal exam.

My intention is not a knock against Professor Mcdonough, who is great in everyother aspect of his teaching, but rather a critique of the testing process that hopefully will be considered for future classes.

Comments
Clear, concise lectures
Rob was very accessible for questions after lecture and in the EconAid center. His lectures were super organized and engaging and his enthusiasm made me want to come to class every day, despite attendance not being mandatory and class being late in the day.
He did a good job teaching
Robert was very engaging in class making learning the difficult content of ECON 101 a whole lot easier to understand. His passion during lecture really shined through, which I as a student appreciated.

Dr. McDonough was a great teacher. I efficiently taught a massive amount of content in one semester. His lectures were consistent, structured, and relevant. My only complaint was that we did not have sufficient practice with certain concepts prior to the exams. While it was nice that there was only one problem set every three weeks, it would have been more beneficial to have one due every week so that we were engaging with the content on a regular basis. The online textbook assignments with each chapter were not sufficient.

Professor Mcdonough taught in an interesting and engaging way, making it far easier to learn the content. There were ample resources (lecture slides, homework problems, problem sets, textbook chapters, etc.) to prepare for exams and to enhance our understanding of the content.

Mcdonough makes Econ interesting with great real world examples.

His lectures were very effective. He did demonstrations for a lot of the concepts, explained things very clearly, and posted the lecture slides after class. He also provided extensive resources for practice before exams (study guide, practice questions for every unit, and a practice exam with an answer key, on top of recitation activities and the homework we completed for each unit). He usually didn't allow questions during lecture as there was so much material to go over and not enough time, but that's what recitation was for, and he definitely did his best (using PollEv, sending out a weekly review of everything we learned and answers to any questions people asked through PollEv, etc.). He also gave us points back on our exams for questions in which there was ambiguous language. I appreciated this, because all professors make mistakes occasionally, but he is one of the few who takes accountability for them and makes sure we aren't affected negatively by them.

Having a different perspective on the readings during the lectures was really helpful.

The professor was a very engaging lecturer which I enjoyed.

Robert explained lectures very thoroughly. However, if you are reading this Robert, please please please change the way you do exams. Or do not state that you are "looking to see how much we know about Econ" bc the exams are more so a test of time management than economic theory. I found that to be extremely frustrating.

Good examples and energetic in class helped

Robert was an engaging lecturer and responded well to student questions. Everything was graded in a timely manner, and the course progression was easy to follow.

The variety of assignments, including the problem sets and achieves, allowed me to practice my knowledge by applying it to real life problems.

I'll start off by stating this, McDonough was great. His lecture was captivating and he was constantly linking content back to key takeaways from the course that made it that even students who weren't interested in Economics outside of getting the pre-req were able to walk away with practical knowledge how to look at the decision systems of the world around us. McDonough was extremely communicative and made a great deal of effort providing material online, making himself and TAs accessible, providing review material for exams, and review opportunities throughout the entire semester. McDonough was extremely fair, he understood when he made the first midterm far too difficult for students and understood and rectified mistakes he had made which was sincerely a nice shift from other professors who place themselves on a pedestal and push blame onto students for their mistakes. McDonough was funny and always had a great suit. I would take another class with him.

My major qualms with this course came around assessment. The second exam was fair and the grade weighting and policies made sense, were forgiving, and made space for students to change course if their grade was going in the wrong direction. My biggest issue was the testing environment. I understand that examinations are important to the course and should be held with great integrity, however, during both midterms the testing environment was stressful, angry, and had a bit too much intensity drawing away from the intent of the assessment. During the second midterm when a student next to me was suspected of cheating, McDonough rushed over, raised his voice, and dragged the student to the front of the room. This gave me an anxiety I didn't even know I had (not of cheating, but just from his intensity), and I couldn't perform for another five minutes, which was not a good addition to an already time–constricted test.

I understand rules and testing policies are important to the integrity of exams and course fairness, but I believe there are a few steps that can be taken to greatly reduce student stress while still underscoring exam rules. The yelling during testing is unnecessary, unhelpful, and unwanted. When students are suspected of cheating, those incidents should be taken care of quietly and discreetly as to not further ruin the fairness of the exam. Testing rules and time limits can be a little more casually explained just with less cursing and anger at the start of an already stressful exam. Even if you just take a few deep breaths, it would really mean a lot to students. I understand that examinations are stressful for you as well, but know that we hear you regardless of your tone and volume.

Other than that, I would just want to see practice exam difficulty closer to the the actual difficulty of the exam, I felt that the practices were always a bit too easy compared to the real tests.

Not only did the time constraint make the tests hard, but the short answer sections seemed to have many degrees of difficulty above any practice in problem sets or homework assignments. This was discouraging.

Prof. McDonough made the classroom feel like a very warm and inclusive environment and I really appreciate that he did not shy away or talk about these topics in a flippant way.

Additionally, I think that tests could have been much easier. I understand that he challenged us to think critically during the tests, but the challenging material combined with the other challenging material presented to us in the other aspects of the course was almost overwhelming in the time frame. To be honest, the fact that he did not allow us to utilize the last 15 minutes of the course for the test was very annoying as I did not understand why he challenged us with the material but did not allow for us to use this time to our benefit. I think future classes should allow for the utilization of those critical 15 minutes.

Professor Mcdonough was enthusiastic and very knowledgable about economics. As someone who had never taken econ before, he made it very easy to understand difficult concepts and always related the material to the real world. He used great examples and made the content interesting.

It is often easy to skip a level if you make one mistake. The main thing is that it is difficult to control. In many cases, everyone gets perfect marks on the written questions. If you get a few correct or wrong questions wrong, you will make a lot of mistakes. The only part of the class that I thought was confusing were the true false portion of exams. I liked how extra credit points were build into the problem sets. Additionally, I liked the reading quizzes; I feel as they helped better my understanding of the material. 
